

## 2013 "Make Your Mark" Bookmark Contest: Official Contest Rules

## **How to Enter the Contest**

• Contest dates are Friday, August 30, through Monday, September 30, 2013.

 Bookmark designs must be submitted on the official Utah Educational Savings Plan (UESP) and Zions First National Bank (Zions Bank) entry form (available at uesp.org/bookmark).

• UESP and Zions Bank are not responsible for lost, misdirected, or late-arriving mail.

• All entries must be received at the UESP office by 5:00 p.m. (MT), Monday, September 30, 2013.

**Judging and Winners.** A panel of judges will award eight winners a \$1,000 UESP college savings scholarship account from UESP and Zions Bank. Winners will include:

- Two kindergarten through 3rd grade students
- Two 4th through 6th grade students
- Two 7th through 8th grade students
- · Two 9th through 12th grade students

Winners will be notified by telephone, e-mail, or U.S. mail by Monday, October 28, 2013. All decisions are final.

**Eligibility.** Contest participants must be:

- · Utah residents
- Either (1) enrolled in kindergarten through 12th grade at a Utah school or (2) school-age students who are homeschooled

The following are ineligible to enter the contest:

- Employees, directors, and agents of the Utah State Board of Regents (USBR), Utah Higher Education Assistance Authority (UHEAA), UESP, Zions Bank, and their respective affiliates, parents, subsidiaries, and advertising agencies; and the immediate family members of all such persons (spouses, parents, siblings, and children)
- Past winners of the "Make Your Mark" Bookmark Contest
   Participants are not required to own a UESP or Zions Bank account to enter the contest.

**Restrictions.** Limit one entry per person. Each winner may only win one scholarship account. The UESP scholarship account may not be used in conjunction with, or as a match for, any other UESP promotion.

**Ownership Rights.** Submitted materials become the property of UESP and will not be returned. UESP will retain ownership and copyrights for all submitted entries. Winning designs may be printed and used by UESP and Zions Bank.

**Disclosure of Identifying Information.** Winners' first names, ages, and school districts may be displayed on the UESP website (uesp.org) along with their artwork. Other personal information, such as last names or phone numbers, is used strictly for internal purposes. By entering the contest, each participant acknowledges that the participant's mailing address and/or e-mail address may be used by UESP for UESP notifications.

**Disqualification.** The following will be ruled ineligible:

- Entries not submitted on the official entry form
- Entries that do not provide sufficient contact information
- Entries containing material protected by copyright or trademark
- Entries that are not the original work of the submitting student

**Information.** Scholarship accounts are designed so the principal and any related earnings must be used for qualified higher education expenses and earnings, if any, will not be subject to federal or Utah state income taxes. However, it is possible that future changes in law

may cause a scholarship account to be taxable, or that the Internal Revenue Service may take the position that a scholarship account is taxable in the year it is awarded or distributed. A participant should consult their own tax adviser for more information. Payment of all federal, state, and local taxes, if any, that result from winning the 2013 "Make Your Mark" Bookmark Contest is the sole responsibility of each winner. All federal, state, and local laws apply. Odds of winning depend on the number of eligible entries. The contest is void where prohibited by law.

**Scholarship Accounts.** Information about the beneficiary required to open the scholarship account must be submitted to UESP no later than three months following the award date. Scholarship accounts may not be converted to cash nor may non-qualified withdrawals of money be made from scholarship accounts.

Scholarship accounts are invested in the FDIC-Insured Savings investment option. Qualified withdrawals from a scholarship account can be used for tuition, fees, books, or required supplies and equipment, but may not be used to pay for room and board. Scholarship account funds may be used at any eligible educational institution, which is any college, university, or technical school that participates in federal financial aid programs for students, not just at institutions in Utah. (Visit fafsa.ed.gov for a list of eligible schools.) Withdrawals from a scholarship account will be sent only to the eligible institution designated on the withdrawal form. UESP reserves the right to request documentation to verify that withdrawn funds were used for qualified higher education expenses. Qualified withdrawals from the scholarship account must start before the beneficiary turns age 22. All withdrawals from the scholarship account must be completed within four years of the initial withdrawal. Unused funds in the scholarship account will be forfeited by the beneficiary.

**UESP Account Investments.** Additional money from a winner's parents/guardians, friends, or family members may not be contributed to a scholarship account; however, individual UESP accounts opened for the beneficiary may receive such contributions. Each account owner or contributor should carefully read the UESP Program Description for more information and consider all investment objectives, risks, charges, and expenses before investing. Investments are not guaranteed by any federal or state agency. However, Federal Deposit Insurance Corporation (FDIC) insurance is provided for the FDIC-insured savings account. The Program Description includes more information about the FDIC-insured savings account. An investment could lose value.
